NOAA's Office of Law Enforcement received information that according to VMS track information the Republic of the Marshall Islands (RMI) fishing vessel FFV LOMALO may have fished inside the US Exclusive Economic Zone (EEZ) within the islands of Howland Baker






On September 15, 2019, WCPFC VMS track lines and other position data revealed that The FV LOMALO did enter the US EEZ Surrounding the Howland and Baker Islands. The vessel's VMS tracks did not appear consistent and indicated possible prohibited fishing activity approximately 1.845 nm inside the US EEZ with clear indications of at least one alleged purse seine fishing set pattern.

A letter requesting an investigation by RMI authorities was then sent to the Marshall Islands Marine Resources Authority (MIMRA)



### Dear Mr. Glen Joseph:

The United States National Oceanic and Atmospheric Administration (NOAA), Office of Law Enforcement (OLE), is conducting an investigation into the activities of one of RMI's flagged fishing vessels. It is the F/V LOMALO, a purse seine commercial fishing vessel.

The above-named vessel is suspected of fishing illegally inside the United States Exclusive Economic Zone (EEZ) surrounding Howland and Baker Islands on the  $15^{\rm th}$  and  $16^{\rm th}$  (Greenwich Mean Time, "GMT") of September 2019.

### The Facts

During 15-16 September 2019, WCPFC VMS track lines and other position data showed that the subject vessel entered the U. S. EEZ surrounding Howland and Baker Islands. The vessel's VMS tracks did not appear consistent with a typical straight-course, steady-speed transit, and was indicative of prohibited fishing activity within the U.S. EEZ. Of note was the length of the VMS and other data tracks that were approximately 1.84 nautical miles (nm.) inside the U.S. EEZ with clear indications of at least two purse seine fishing patterns within the U.S. EEZ.

### Alleged Offense

Under U.S. law, specifically, 16 United States Code§ 1857 Sec. 307(2)(B) Magnuson- Stevens Fishery Conservation and Management Act:

"It is unlawful for any vessel other than a vessel of the United States, and for the owner or operator of any vessel other than a vessel of the United States, to engage in fishing, except recreational fishing permitted under section 201(i), within the exclusive economic zone, or for any anadromous species or Continental Shelf fishery resources beyond such zone, unless such fishing is authorized by, and conducted in accordance with, a valid and applicable permit issued pursuant to section 204(b)(c) or (d); or..."

### Request for Assistance

Based on the information collected and reviewed to date, NOAA OLE has reason to believe that on or about 15-16 September 2019 the Republic of Marshall Islands Flag F/V LOMALO is suspected of illegally conducting fishing operations inside the EEZ of the United States of America.

Thus, NOAA OLE is requesting that Republic of Marshall Islands authorities collect and submit to NOAA OLE fishing vessel logbooks, any Observer records, and any other records relevant to these aforementioned cited incidents within the U.S. EEZ.

NOAA OLE is also requesting that Republic of Marshall Islands authorities conduct an investigative inspections of the above named subject fishing vessel regarding physical and electronic records maintained onboard, and data files saved in their respective electronic navigational equipment during the cited times/dates that said vessel was suspected of conducting fishing operations inside the EEZ of the U.S. In particular, please provide NOAA OLE with copies of any documents, records, and/or data that indicates fishing inside the U.S. EEZ as specified in Attachment # 1 of this letter.

Please know that NOAA OLE is honored to offer assistance to you and your agency in this matter upon your request. Is you so desired, it would be my privilege to send NOAA OLE Special Agents to Republic of Marshall Islands to work alongside your staff in the inspection of the <u>subject fishing</u> vessel, participate in any interviews of crewmembers and/or observer(s), and in the examination of any documents and/or data recovered in this investigation.

### Interview of Observer and Access to Observer Records

If an observer was onboard the F/V LOMALO during these <u>above cited</u> trip, we request the Republic of Marshall Islands examining authorities interview the observer for the vessel and report their responses to NOAA OLE concerning the following points:

- Their presence, role and responsibilities on the F/V LOMALO on 15-16 (GMT) September 2019;
- 2. The particulars of the fishing voyage, including dates of departure and return;
- Fishing activities during the voyage, including but not limited to target species, gear and fishing procedures used by the vessel;
- The start and ending locations, and times (hour) of fishing sets and retrievals on or about 15-16 (GMT) September 2019;
- 5. Any conversations with the captain or crew regarding the U.S. EEZ boundary areas.

We further request that copies of the aforementioned observer records created for these trips and dates <u>be provided</u> to NOAA OLE for our review.

### Business Records

We request copies of all records regarding the owners and operators of the F/V LOMALO, as well as the vessel's positions, date and time of positions, and type of activity taking place on (15-16 GMT) September 2019. Examples of the types of records sought by NOAA OLE include:

- Documentation that identified ownership and the operator of the vessel from 15-16 (GMT) September 2019;
- 2. The vessel's navigation logs for 15-16 (GMT) September 2019;
- 3. The catch reports, including offload tally's/transhipment records;
- Documents containing fishing information for the sets on 15-16 (GMT) September 2019; and
- The data maintained within the memory or downloaded from any of the vessel's computers or electronics regarding their respective positions on 15-16 (GMT) September 2019.

### Interview of Vessel Crew

We request that examining authorities interview and report the results of these interviews to NOAA OLE of the F/V LOMALO's captain, fishing-master and any other crewmember that directed fishing activities or documented locations of fishing activity regarding the following:

- Their presence, role and responsibilities on their respective vessel during 15-16 (GMT) September 2019;
- 2. The particulars of the fishing voyage, including dates of departure and return;
- Fishing activities during the voyage, including but not limited to target species, location, gear, and the start and ending locations of fishing sets on or about 15-16 (GMT)

### September 2019; and

- 4. The manner in which all at-sea activities are reported in the vessel's logbooks, including
  - a. Who makes the entries;
  - b. When entries are typically recorded;
  - c. How entries are recorded, i.e. hand written or electronically; and
  - The location of original logbooks and any source documents used to prepare these logbooks;

Government Reports / Data

Please provide NOAA OLE with the results of your inspections of the F/V 15-16 (GMT) September 2019 when representatives from the Government of the Republic of Marshall Islands complete them, including:

- 1. The name and title of the official;
- 2. The date and location of the inspection;
- 3. The nature and extent of the inspection;
- The nature and extent of any inspection of the vessel's VMS and electronic charting systems; and

### Dear Mr. Glen Joseph:

The United States National Oceanic and Atmospheric Administration (NOAA), Office of Law Enforcement (OLE), is now pursuing further action into the activities of RMI's purse seine commercial fishing vessel the F/V LOMALO that was suspected of fishing illegally inside the United States Exclusive Economic Zone (EEZ) surrounding Howland and Baker Islands on the 15<sup>th</sup> and 16<sup>th</sup> (Greenwich Mean Time, "GMT") of September 2019.

A formal letter requesting assistance in the investigation dated November 7, 2019, was previously forwarded to your office regarding that a full investigation be conducted. We have been patiently waiting on a response from your office for over one year now in regards to this request and still haven't received any response. May we remind you of each member's obligation under the WCPFC Conservation and Management Measures which require that the flag States to provide evidence to the injured State.

According to Article 25 under the Convention, "Each member of the Commission shall, to the extent permitted by its national laws and regulations, establish arrangements for making available to prosecuting authorities of other members evidence relating to alleged violations."

RMI's failure to comply under the Convention in paragraph 2 states, "Each member of the Commission shale, at the request of any other member, and when provided with the relevant information, investigate fully any alleged violation by fishing vessels flying its flag of the provisions of this Convention or any conservation and management measure adopted by the Commission. A report on the progress of the investigation, including details of any action taken or proposed to be taken in relation to the alleged violation, shall be provided to the member making the request and to the Commission as soon as practicable and in any case within two months of such request and a report on the outcome of the investigation shall be provided when the investigation is completed."

The United States National Oceanic and Atmospheric Administration (NOAA), Office of Law Enforcement (OLE), is investigating the activities of RMI's purse seine commercial fishing vessel the F/V LOMALO which was suspected of fishing illegally inside the United States Exclusive Economic Zone (EEZ) surrounding Howland and Baker Islands on the 15<sup>th</sup> and 16<sup>th</sup> (Greenwich Mean Time, "GMT") of September 2019.

A letter dated November 7, 2019, requesting RMI investigate this infringement of U.S. sovereignty and breach of international rules was previously forwarded to your office from NOAA OLE. OLE has waited on a response from your office for over one year. Due to RMI's failure to promptly investigate and provide NOAA OLE with the results of the investigation, NOAA OLE is conducting its own investigation and is requesting relevant documents from RMI. Keep in mind that each member of WCPFC has an obligation under Article 25 to cooperate with investigations and to provide a requesting member with the information necessary to undertake such investigations.

RE : Request for assistance in the investigation of Republic of the Marshall Islands Flagged Fishing Vessel LOMALO.

Firstly, regrets for the delay of response in a timely manner as re-investigations required additional time for the Flag State, with limited resources, to effectively and diligently scrutinize all documentation pertaining to the alleged time and date (September 15-16, 2019), especially for a SIDS nation.

Secondly, the Marshall Islands Marine Resources Authority ('MIMRA'), on behalf of the Government and People of the Republic of the Marshall Islands, has received your letter dated April, 27, 2020 in relation to the above-mentioned subject matter. As the Flag State, MIMRA has diligently taken steps to conduct our flag state investigation regarding the fishing vessel, Lomalo (V7UB4), and also contacted the owner of this vessel, Pan Pacific Fishing (RMI), Inc. ('the Company') regarding the allegations of alleged infringement purported to have occurred on 15-16 September, 2019 inside the United States Exclusive Economic Zone (EEZ) surrounding Howland and Baker Islands.

From May 1 2020 to March 2, 2021, MIMRA had initiated another re-investigation per the request by your Office. In this regard, the Flag State contacted the Vessel Operator regarding the complaint for allegedly fishing within the closed area (Howland and Baker Islands), while at the same time MIMRA has compiled relevant documentation and snapshots of the Vessel, Lomalo (V7UB4). After reviewing the Observer's relevant journal pages we had reviewed the case file and have not received any confirmation of the Observer's observance of alleged illegal fishing within the Howland and Baker Islands, there is insufficient evidences to warrant any violation against the Vessel Operator.



### Observer Statement for alleged illegal fishing of FV Lomalo

Observer believed that the vessel was fishing at the High Sea very close to Howland and Baker EEZ according to recorded Set and end positions around aforementioned reported times (2200 hrs on September 15 to 0500 hrs on September 16) cross checked and found to be less than a mile outside the US EEZ. There were three sets carried out (as from Form PS-2):

- Start of Set#15 at1849hrs September 15, Coordinates; 03\*51.899'N, 174\*54.905'W, End of Set at 2138hrs September 15, Coordinates; 03\*50.171'N, 174\*58.550'W.
- Start of Set#16 at 2254hrs September 15, Coordinates; 03°45.707'N, 175°02.345'W, End of Set at 0149hrs September 16, Coordinates; 03°46.524'N, 175°04.895'W.
- Start of Set#17 at 0401hrs September 16, Coordinates; 03\*56.925'N, 175\*23.538'W, End of Set at 0651hrs September 16, Coordinates; 03\*57.007'N, 175\*26.320'W.

These were the only positions recorded by Observer and he couldn't obtain positions during setting operations while vessel may have drifted into Howland and Baker zone but positions obtained were start and end of sets only. The observer was engaged in other duties like sampling and catching up with data entries and couldn't check the GPS or track plotter while drifting.

To observer's experience;

- Some vessels can start main engine and move away or move out slowly from the prohibited zone during hauling, brailing or before skiff gets onboard. This could be the case that vessel moved away before set ends.
- Vessels use different software as 'track plotters' which in some cases; EEZ marked zones could be
  different from each other. E.g. Vessel is already inside the zone but the other software states that it is
  still outside.

Attached with Statement is a plot on Start of Sets (marked green) and end of sets (marked red) but vessel could have drifted inside the zone which was unnoticed by observer. Drifting pattern is shown in set #15 [the furthest from the zone) bearing west-south-west due to the oean current and wind flow. The other two sets closer to the zone drifting pattern seems different which shows vessel could have moved out before set ends. If the vessel Lomalo is to be prosecuted for illegailly entering and fishing in the US Zone (Howland and Baker EEZ) then it should be and observer can prove that setting position is just 0.3 nautical miles away from the US EEZ. A great possibility, that the vessel can drift into the zone due to ocean current and wind. This is obviously proven by the track records sent by NOAA. The vessel Operators know that observers have to record start of set and end of set positions during setting, so they are concerned more on these, other than positions during available.

Firstly, the company checked the logsheet on board. The vessel started of fishing set at 2255 15th September, position 03°46'N,175°02'W ,and end of set at 0148 in the position 03°47'N,175°05'W on 16th September 2019(GMT) as specified in Attachment#1. After double checking, the said netting position is in High Sea.

Secondly, the company checked the VMS, such as buoy monitoring system(BMS) on board, IFIMs by PNA, overseas fishery service platform(OFSP) by China. The all positions of the vessel on the alleged date are located in the High Sea in IFIMS and OFSP as specified in Attachment#2 #3 and Attachment#4.

Immediately, the company checked the electronic navigational equipment on board. The vessel track line of the alleged date is already removed automatically due to a long time. Based on the setting fish positions in LOGSHEET, the vessel marks the closest approach points respectively on electronic navigational equipment as specified from Attachement#5 to Attachment#9, which shows that the positions are located in the High Sea.

According to the above, the company believe that the vessel completed her netting in the High Sea on the alleged date.

Hereto, to avoid similar affairs in the further, the company will announce that the owned vessels must be 5 nautical miles (FROM 1 JAN 2020)away from the prohibited area using in current electronic navigational equipment. Furthermore, the company will look for accurate electronic charts to solve such problems completely.

Finally, we appreciate your consideration of the vessel situation at that time and feel free let us know if you have further request.





Please see the attached written statements that you had signed earlier as it says "Observer believed that the vessel was fishing at the High Seas very close to Howland Baker EEZ according to the recorded Set and end positions around aforementioned reported times (2200 hrs on September 15 to 0500 hrs on September 16) cross checked and found to be less than a mile outside the U.S. EE2"

Please take a closer look at Set #16: "Start of Set #16 at 2254 hrs September 15, Coordinates;  $03^{\circ}45.707$  N,  $175^{\circ}02.345$  W, End of Set at 0149 hrs September 16, Coordinates;  $03^{\circ}46.524$  N,  $175^{\circ}04.895$  W."

We believe these coordinates start and end inside the U.S. EEZ boundary lines. Are these both a correct and accurate statement that you had signed earlier? If not then please explain further.

I, the observer cannot change these coordinates and if you find them inside the U.S EEZ Boundary lines, then let them be proof that the vessel had crossed into the zone and be penalized accordingly. I may change what I believed that the vessel was fishing in the High Sea very close to the U.S zone. Statement changed to, "I didn't notice that the vessel was already inside the U.S zone because the e-map (Orb Map) I was using stated that the vessel was still outside". If the vessel plead their innocence depending on my report then it is inappropriate because these coordinates I gave are already inside the U.S zone as abovementioned. I may not have noticed where they are plotted but my coordinates prove them guilty. Also if they plead that I let them operate there, then understand that observers have no authority to give orders to the vessel but just recorded what was observed. The vessel knows the rule but wasn't to take the risks.

The vessel wouldn't want that.

Do you have anything you wish to add to this statement? I think I already clarify everything.

I have read this statement consisting of <u>5</u> pages and have initialed all corrections. I fully understand its entire contents and declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.

### Dear Sir:

The National Oceanic and Atmospheric Administration (NOAA), Office of General Counsel, is responsible for prosecuting violations of the Magnuson-Stevens Fishery Conservation and Management Act on behalf of the U.S. Secretary of Commerce.

An investigative report prepared by the NOAA Office of Law Enforcement regarding events that occurred on September 15-26, 2019, was referred to this office for prosecution. Based on our review of that report, this office has determined that you violated the Magnuson-Stevens Fishery Conservation and Management Act. This office hereby assesses a civil monetary penalty of \$99,300.00 US dollars for your violation of this statute.

Accordingly, NOAA issues the enclosed Notice of Violation and Assessment ("Notice") to Pan Pacific Fishing (RMI) Inc. This is a civil administrative action, not a criminal proceeding. The Notice and the enclosed copy of the regulations governing NOAA civil administrative proceedings explain your rights in this process. Read these documents carefully.

If you choose not to contest the charged violation and the civil monetary penalty assessed above, you may resolve this matter by signing the Settlement Agreement, which is included with the Notice.

To encourage your prompt acceptance of responsibility for this violation and early resolution of this matter, NOAA is willing to settle this case for a reduced amount. If you sign the Settlement



Agreement within 30 days after your receipt of the Notice, the base penalty assessed in the Notice will be reduced by 10%. Therefore, the amount of your assessed penalty of \$99,300.00 US dollars would be reduced to \$89,370.00 US dollars. This offer expires 30 days after your receipt of the Notice, but may be extended by the Enforcement Attomey for an additional 30 days upon request. After the expiration of this early settlement offer, NOAA will proceed against you for the full-assessed penalty amount of \$99,300.00 US dollars, as indicated in the Notice. If you seek to settle the case after the expiration of the 30-day early settlement period, you must contact the undersigned Enforcement Attomey, who will discuss settlement terms and conditions with you or your legal representative.

By signing the Settlement Agreement, you waive your right to a hearing and agree to pay the civil monetary penalty. To resolve the case at this point and on these terms, sign and date the Settlement Agreement at the bottom of the last page and return it to me by email at <u>Elizabeth osullivan@noaa.gov</u> or by mail to my attention:



At the hearing, the administrative law judge will conduct an independent determination of whether the charged violation occurred and, if so, what the penalty should be. The administrative law judge is not bound by the amount assessed in the Notice, but may, after taking into account all of the factors required by applicable law, assess a penalty up to the maximum amount provided by law.

IMPORTANT: If you fail to respond within 30 days of your receipt of the Notice by either 1) signing and returning the enclosed Settlement Agreement, 2) contacting me to seek to have the Notice amended, modified, or rescinded, 3) requesting a hearing, or 4) requesting an extension of time to respond to the Notice, you will become liable for the violation and assessed penalties described in the Notice.







### Dear Chief Wang:

The United States National Oceanic and Atmospheric Administration (NOAA), Office of Law Enforcement (OLE), is conducting an investigation into the activities of the Chinese-flagged fishing vessel MAN FU TSAI No. 5, a commercial longline fishing vessel.

This vessel is suspected of fishing illegally inside the Pacific Remote Islands Marine National Monument surrounding the Johnston Atoll U.S. Exclusive Economic Zone (EEZ), on the dates of December 31, 2021, through January 4, 2022.

### Alleged Offense

Under U.S. law, specifically, 16 United States Code§ 1857 Sec. 307(2) (B) Magnuson-Stevens Fishery Conservation and Management Act:

"It is unlawful for any vessel other than a vessel of the United States, and for the owner or operator of any vessel other than a vessel of the United States, to engage in fishing, except recreational fishing permitted under section 201(i), within the exclusive economic zone, or for any anadromous species or Continental Shelf fishery resources beyond such zone, unless such fishing is authorized by, and conducted in accordance with, a valid and applicable permit issued pursuant to section 204(b)(c) or (d); or..."

### Request for Assistance

Based on the information collected and reviewed to date, NOAA OLE has reason to believe that on January 2, 2022, the Chinese Flag F/V Man Fu Tsai No. 5 is suspected of illegally conducting fishing operation inside the EEZ of the United States of America on or about December 31, 2022 through January 4, 2022. Please note that all dates and times in this document are in international standard Coordinated Universal Time (UTC).

NOAA OLE is requesting that China authorities conduct an investigative inspection of the F/V Man Fu Tsai No. 5 regarding physical and electronic records maintained onboard, and data files saved in their respective electronic navigational equipment during cited times/dates that the subject vessel is suspected of conducting fishing operations inside the EEZ of the United States. In particular, please provide NOAA OLE with copies of any documents, records, and/or data that indicates fishing inside the U.S. EEZ as specified in Attachment #1 of this letter.

Please know that NOAA OLE is honored to offer assistance to you and your agency in this matter upon your request. If you so desire, it would be my privilege to travel to China to work alongside your staff in the inspection and examination of any documents and/or data recovered in this investigation.

The vessel position reporting is in compliance with the requirements stipulated in the related CMM. In addition, the positions above-mentioned F/V reported are 670 miles away from the Johnston Atoll. As such, there is no opportunity for this vessel to engage in the illegal fishing activity within the Johnston Atoll. Attached please find the vessel position reports of the F/V MAN FU TSAI No. 5. We would appreciate further information from your side to facilitate our investigation.




