- The various Fisheries Administrative Order, BFAR Circulars and DA Administrative Orders are all implementing rules and regulations



SUBJECT: RULES AND REGULATIONS GOVERNING DISTANT-WATER

- International Fishing Permit
- Registered with the RFMO or the Coastal State
- Compliance with rules and regulations of the RFMO; Coastal State;
- Compliance with the safety, manning and other requirements of MARINA; concerned national fishery agencies;
- Compliance with vessel marking and specification requirements of the RFMO;
- Fisheries observer coverage in accordance with the conservation and management measures of the RFMO (catcher vessels);
- Equipped with a two-way ALC; one-way for light boats
- Timely Reporting of Catch, Vessel Entry and Exit
- Inspection and Monitoring of Port Landings in authorized port
- Declaration of Landing in Foreign Ports.

TITLE: TRACEABILITY SYSTEM FOR FISH AND FISHERY PRODUCTS

- Establishes traceability system for wild-caught and fiarmed fish; other aquatic products
- Data requirements for business operators in the supply chain
- Competent authority to refer to Observer reports, VMS and Tracking, LGU registration
- Responsibilities of Compentent Authority to ensure compliance to traceability requirments
