



"Chain" of IUU F


Fishing vessel registration Forgery, bribery, doubleflagging, size markdown

Distribution/export Fish-unloading outside the designated port, falsification of export documents, illegal export

A ccounting for profit and tax calculation Marking down profit to avoid taxes, fictitious business address'



Fishing operation


No license, use of destructive or banned fishing gear, not in the designated fishing area, transshipment, VMS not active

Processing

Processing license only being a requirement for getting a fishing license, false labelling, or high grading

Sales


Tax evasion through counterfeited labels and direct sales
