


National Fisheries Law and Regulation Relevant to Combat IUU Fishing




Thailand's management and conservation of aquatic living resources.

> There is a comprehensive legal framework governing the management of fisheries and fleet, monitoring, control and surveillance to prevent and deter illegal fishing, and appropriate sanctions proportional to the seriousness of wrongdoings

The main legal framework governing the management of aquatic resources in Thailand can be summarized in the following figure:




